# CERTIFICATE OF SURVEY 

## PARENT PARCE LEGAL DESCRIPTION

(AS RECORDED IN LBER 673, PAGE 946, ST. JOSEPH COUNTY RECORDS)
All that part of the Southwest $1 / 4$ of Section 28, Township 6 South, Range 10 West described as:
Commencing at the West $1 / 4$ corner of said Section 28, and running thence South $89^{\circ} 50^{\prime} 30^{\prime \prime}$ East along the $1 / 4$ line, 930 feet to the POINT OF BEGINNING of this description; thence South $89^{\circ} 50^{\prime} 30^{\prime \prime}$ East along said $1 / 4$ line, 389.50 feet, thence South $12^{\circ} 56^{\prime} 26^{\prime \prime}$ West, along a random traverse line, 512.70 feet to an iron bar, thence North $89^{\circ} 50^{\prime} 30^{\prime \prime}$ West 274.19 feet; thence North $00^{\circ} 03^{\prime} 24^{\prime \prime}$ West 500 feet to the POINT OF BEGINNING. Also all that land lying between the above random traverse line and the Prairie River, as bounded by the North and South property lines extended Easterly.
Subject to easements, conditions and restrictions of record.

Lands located in the Township of Nottawa, County of St. Joseph, Michigan described as:
Commencing at the West $1 / 4$ Corner of Section 28, Town 6 South, Range 10 West, Nottawa Township, St. Joseph County, Michigan; thence South $89^{\circ} 34^{\prime} 11^{\prime \prime}$ East along the East \& West $1 / 4$ line of said Section 1498.50 feet to the POINT OF BEGINNING; thence continuing South $89^{\circ} 34^{\prime} 11^{\prime \prime}$ East 103.65 feet to Meander Point "A" being on the Westerly bank of the Prairie River; thence continuing South $89^{\circ} 34^{\prime} 11^{\prime \prime}$ East approximately 38 feet to the centerline of the Prairie River; thence southerly along the centerline of said Prairie River to a point which is 64.50 feet south of, as measured at right angles, to the East \& West $1 / 4$ line; thence North $89^{\circ} 34^{\prime} 11^{\prime \prime}$ West parallel with said East \& West $1 / 4$ line approximately 46 feet to Meander Point " B " on the Westerly bank of the Prairie River, said Meander point " B " being the following courses and distances from afore mentioned Meander Point "A": South $00^{\circ} 04^{\prime} 28^{\prime \prime}$ East 17.72 feet; thence South $53^{\circ} 56^{\prime} 47^{\prime \prime}$ West 19.75 feet; thence South $04^{\circ} 20^{\prime} 29^{\prime \prime}$ West 35.12 feet to said Meander Point "B"; thence continuing North $89^{\circ} 34^{\prime} 11^{\prime \prime}$ West 85.54 feet; thence North $00^{\circ} 25^{\prime} 49^{\prime \prime}$ East 64.50 feet to the POINT OF BEGINNING.
